These refund stipulations adhere to the NYC LIONS YOUTH FOOTBALL ORGANIZATION

To request a refund of registration fees please send an email with the subject line "REFUND" and the name, and Head Coaches name to.

The body of the email should state why you are withdrawing your child and arrangements must be made to return any uniforms and/or equipment before a refund can be issued.

Refund Checks can take up to 2 weeks to process depending on the time the refund is requested. You must request a refund and receive a confirmation

Before 7/1

90% refund of the total amount paid on behalf of our child. We do not give 100% fee because once you register there is administrative tasks performed which incur costs. Refund excludes any credit card processing fees the organization incurred, as those cannot be refunded.

Between 7/1 and the First game.

75% refund of the total amount paid on behalf of our child. Refund excludes any credit card processing fees the organization incurred, as those cannot be refunded.

No refunds will be issued after the first game of the season or 08/22 in which the year this document was signed, whichever ever may occur first, regardless of reason.

DISPUTE RESOLUTION POLICY: You hereby understand and acknowledge that all civil disputes between the NYC Lions Youth Football Organization and any and all affiliated parties will be subject to binding arbitration in the locale of the NYC Lions Youth Football Organization Office in New York City, New York in accordance with Local/federal law under the guidelines and rules of the American Arbitration Association. As a participant within the NYC Lions Youth Football Organization you hereby agree that this binding arbitration shall be in lieu of any litigation by and between yourself, NYC Lions Youth Football Organization and any and all affiliated parties. You also understand and agree that if you contest any decision or ruling of the NYC Lions Youth Football Organization and seek other recourse, that you will reimburse NYC Lions Youth Football Organization for all legal fees and expenses it reasonably incurs. If any portion of this form shall be deemed unenforceable or invalid, the remainder shall remain in full force and effect.

CODE OF CONDUCT AGREEMENT

In order to uphold the goals of the NYC Lions Youth Football Organization and ensure that all participants have the benefit of a safe and fun learning environment, all parents and guardians including other adults and attendees of NYC Lions Youth Football Organization events, including but not limited to practices, competitions, fundraising events, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times.

Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a NYC Lions Youth Football Organization event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave a NYC Lions Youth Football Organization event. The NYC Lions Youth Football Organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all NYC Lions Youth Football Organization events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period.

Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all NYC Lions Youth Football Organization events for one year from the date of the offense, and their children may also be removed from any and all NYC Lions Youth Football Organization programs for that same period of time. After the ban has expired, if the individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all NYC Lions Youth Football Organization events and the individual's children may also be permanently removed from any and all NYC Lions Youth Football Organization programs.

connection with my child's participation. I further agree that this waiver, release and assumption of risks are to be binding on the heirs and assigns of the undersigned.

I further agree to indemnify and to hold The NYC Lions Youth Football Organization (its officers, employees, agents and volunteers) free and harmless from any loss, liability, damage, cost or expense which they may incur as a result of any injury and/or property damage that I or my child may cause or sustain while participating in this activity.

In case of a medical emergency, I hereby give permission to NYC Lions Youth Football Organization and Volunteers to order treatment for my child, including any necessary medical treatment and x-rays. I also hereby give permission to NYC Lions Youth Football Organization and Volunteers to disclose the information contained on the Emergency Medical Card to medical personnel. I understand that an attempt will be made to reach me by phone when a diagnosis is completed. I agree to pay all medical, hospital, or other expenses, which my child or I may incur as a result of such treatment.

NYC Lions Youth Football Organization does not disclose your nonpublic personal medical and financial information, except as required or permitted by law. The NYC Lions Youth Football Organization also does not provide any medical or other insurance protection.
